## INFORMATION NOTE ON NECESSARY REVISIONS TO THE EXISTING DOCUMENTS ADOPTED BY THE JOINT IMPLEMENTATION SUPERVISORY COMMITTEE

### A. Background

- 1. At its sixteenth meeting, the Joint Implementation Supervisory Committee (JISC) requested the secretariat, taking into account the JISC's deliberations on the development of the determination and verification manual (DVM), to present an analysis to the JISC at its seventeenth meeting on necessary revisions to existing documents adopted by the JISC, on which the draft DVM is based, to ensure consistency between the DVM and these documents.
- 2. Based on this, the secretariat prepared this note to provide an overview of the feedback received during the call for public inputs on the contents of a DVM from 27 April until 17 May 2009 and also the inputs from the roundtable consultations with interested stakeholders on the development of a DVM and joint implementation programme of activities (JI PoA) on 16 June 2009. Inputs were received from the following organizations: Climate Experts, International Emissions Trading Association (IETA), Japan Quality Assurance Organization (JQA), Mitsubishi UFJ Securities (Mitsubishi), TÜV Rheinland Immissionsshutz und Energiesysteme GmbH and the World Bank, as well as from the roundtable consultation held in conjunction with the sixteenth meeting of the JISC.

## B. Analysis

- 3. The secretariat has identified inputs received from the organizations mentioned above that may necessitate a revision of existing JISC procedures, guidelines and forms. A summary is provided in Tables 1 and 2 below. General considerations for information and formatting of the DVM were not included.
- 4. The secretariat identified 35 inputs on 8 general topics. These are summarized in Table 1.

Several requests also pertain to the guidelines for users of the JI PDD form.
