Note by the secretariat

- 1. The Joint Implementation Supervisory Committee (JISC), at its fourteenth meeting, decided to develop procedures for programmes of activities under the verification procedure under the JISC (JI PoA procedures), in accordance with paragraph 6 of decision 5/CMP.4.
- 2. At its sixteenth meeting the JISC requested the secretariat to prepare, together with the second draft of the JI PoA procedures, the forms for submitting a JI PoA.
- 3. The JISC adopted the JI PoA procedures at its eighteenth meeting, together with the JI PoA design document form (JI PoA DD), and the guidelines for users of the JI PoA DD. The JISC also adopted a revised version of the glossary of JI terms considering the modifications required by the approval of the JI PoA procedures.
- 4. The following draft forms that are currently used in the verification procedure under the JISC reflect revisions to incorporate the JI PoA procedures. Minor additional formatting modifications were also performed in order to simplify the use of the forms. The following draft forms are enclosed below:
