Bureau Veritas Certification has performed the 2nd periodic verification of the JI Track II Project "YARA KÖPING S2 N2O ABATEMENT PROJECT IN SWEDEN", which applies the project specific approach (using a methodology for baseline setting and monitoring developed in accordance with appendix B of the JI guidelines), AM0034 version 03.4 (with validated deviations) and AM0028 version 04.2 (for monitoring of project emissions).

The verification was performed on the basis of UNFCCC criteria and the host country criteria and also on

the criteria given to provide for consistent project operations, monitoring and reporting.

The verification consisted of the following three phases: i) desk review of the project design and the baseline and monitoring plan; ii) follow-up interviews with project stakeholders; iii) resolution of outstanding issues and the issuance of the final verification report and opinion.

The management of YARA AB is responsible for the preparation of the data on GHG emission and the reported GHG emission reductions of the project on the basis set out within the project Monitoring and Verification Plan indicated in the final PDD version 8 issued on 02/09/2011 and Monitoring plan revision provided in the Monitoring Report version 02 dated 27 January 2012. The development and maintenance of records and reporting procedures in accordance with that plan, including the calculation and determination of GHG emission reductions from the project, is the responsibility of the management of the project.

Bureau Veritas Certification verified the Project Monitoring Report version 02 dated 20 April 2012 for the reporting period as indicated below. Bureau Veritas Certification confirms that the project is implemented as planned and described in the approved project design documents. The installed equipment being essential for generating emission reduction runs reliably and is calibrated appropriately. The monitoring system is in place and the project is generating GHG emission reductions.

Bureau Veritas Certification can confirm that the GHG emission reduction is accurately calculated and is free of material errors, omissions or misstatements. Our opinion relates to the project's GHG emissions and resulting GHG emission reductions reported and related to the approved project baseline and monitoring, and its associated documents.
