1 INTRODUCTION

UAB Silales vejo elektra has commissioned Bureau Veritas Certification to verify the emission reductions of its "Wind Power Farm in Buciai and Kadariai Villages Joint Implementation Project" (hereafter called "the project") located near Buciai and Kadariai Villages, Silale district, Lithuania. This report summarizes the findings of the verification of the project, performed on the basis of UNFCCC criteria, as well as the criteria given to provide for consistent project operations, monitoring and reporting.

The order includes the 2nd periodic verification of the project for the period 01/10/2012-31/12/2012.

1.1 Objective

Verification is a periodic independent review and ex post determination by an Accredited Independent Entity of the monitored reductions in GHG emissions during a defined verification period.

The objective of verification can be divided in Initial Verification and Periodic Verification.

UNFCCC criteria refer to Article 6 of the Kyoto Protocol, the JI rules and modalities and the subsequent decisions made by the JI Supervisory Committee, as well as the host country criteria.

1.2 Scope

The verification scope encompasses an independent and objective review and ex-post determination of the monitored reductions in GHG emissions by the Accredited Independent Entity (AIE). The verification is based on the submitted monitoring report, the determined project design documents monitoring plan and determination report. verification reports, the applied monitoring methodology, decisions, clarifications and guidance from the CMP and the JISC and any other information and references relevant to the project activity's resulting emission reductions. These documents are reviewed against the requirements of the Kyoto Protocol, the JI Modalities and Procedures and related rules and guidance and also against national Estonian JI Guidelines. The verification is not meant to provide any consulting towards the Client. However, stated requests for clarifications, corrective and/or forward may provide input for improvement of the project monitoring towards reductions in GHG emissions.

2 METHODOLOGY

The overall verification, from Contract Review to Verification Report & Opinion, was conducted using Bureau Veritas Certification internal procedures.

In order to ensure transparency, the verification protocol was customized for the project according to version 01.1 of the Joint Implementation Determination and Verification Manual, issued by the Joint Implementation Supervisory Committee at its 19 meeting on 04/12/2009. The protocol shows, in a transparent manner, the criteria (requirements), means of verification and results from verifying the identified criteria. The verification protocol serves the following purposes:

- It organizes, details and clarifies the requirements a JI project is expected to meet;
- It ensures a transparent verification process where the verifier will document how a particular requirement has been verified and the result of the verification.

The completed determination protocol is enclosed in Appendix A to this report.

2.1 Review of Documents

The Monitoring Report (MR) version 1 dated 26/02/2013 submitted by UAB Silales vejo elektra and additional background documents related to the project design and baseline, i.e. the country Law, Project Design Document (PDD), Project Determination Report, Guidance on criteria for baseline setting and monitoring, Host party criteria, Kyoto Protocol, Clarifications on verification requirements to be checked by an Accredited Independent Entity were reviewed.

The verification findings presented in this report relate to the project as described in the PDD Version 1.4, dated 07/11/2011 and the Monitoring Report version 1 dated 26/02/2013.

2.2 Follow-up Interviews

On 28/02/2013 Bureau Veritas Certification performed on-site interviews with project stakeholders to confirm selected information and to resolve issues identified in the document review. A representative of UAB Silales vejo elektra was interviewed (see 5 References). The main topics of the interviews are summarized in Table 1.

2.3 Resolution of Clarification, Corrective and Forward Action Requests

The objective of this phase of the verification is to raise the requests for corrective actions and clarification and any other outstanding issues that need to be clarified for Bureau Veritas Certification positive conclusion on the GHG emission reduction calculation.

If the Verification Team assessing the monitoring report and supporting documents identifies issues that need to be corrected, clarified or improved with regard to the monitoring requirements, it should raise these issues and inform the project participants of these issues in the form of:

(a) Corrective action request (CAR), requesting the project participants to correct a mistake that is not in accordance with the monitoring plan;

- (b) Clarification request (CL), requesting the project participants to provide additional information for the AIE to assess compliance with the monitoring plan;
- (c) Forward action request (FAR), informing the project participants of an issue, relating to the monitoring that needs to be reviewed during the next verification period.

To guarantee the transparency of the verification process, the concerns raised are documented in more detail in the verification protocol in Appendix A.

3 VERIFICATION CONCLUSIONS

In the following sections, the conclusions of the verification are stated.

The findings from the desk review of the original monitoring documents and the findings from interviews during the follow-up visit are described in the Verification Protocol in Appendix A.

The Clarification, Corrective and Forward Action Requests are stated, where applicable, in the following sections and are further documented in the Verification Protocol in Appendix A. The verification of the Project resulted in 0 Corrective Action Request, 0 Clarification Requests, and 0 Forward Action Request.

The number between brackets at the end of each section corresponds to the VVM paragraph.

3.1 Remaining issues and FARs from previous verifications.

There are no remaining issues and FARs from previous verification.

3.2 Project approval by Parties involved (90-91)

Written project approval has been issued from the Investor party (The Netherlands) by the DFP (NL Energy and climate change) of that Party when submitting the first verification report to the secretariat for publication in accordance with paragraph 38 of the JI guidelines, at the latest (LoA is dated 10/04/2012).

The abovementioned written approval is unconditional.

3.3 Project implementation (92-93)

The project involves a 13,8 MW wind farm consisting of 6 Siemens SWT-2.3-101 type wind turbines and the necessary infrastructure for connection to the power distribution grid.

The wind farm was connected to the grid on September 2011. The contract for electric power dispatch was signed on 22/12/2011 with grid operator LIETUVOS ENERGIJA, AB. The official commissioning document recognizing that the wind power park (including the all required infrastructure) was built according to the applicable national legislation was issued on 11/05/2012 by national authorities.

A noise monitoring test is required for this type of projects, and this test was carried out by a notified National Public Health Surveillance Laboratory. Test report (issued on 15/11/2011) confirmed that the noise level is in accordance with the requirements of hygienic norm HN 33:2007.

Electric power meter is installed according to the requirements of the national legislation: the accuracy class for this type of measurement devices is 0,5 s (should be not less than 0,5 s).

Hence, it can be confirmed that the project has been implemented and the equipment has been installed as specified in the PDD and according to the national legislation.

On 20th of December 2012, the reorganization of Vėjo Elektra, UAB and Lariteksas, UAB was finished. After the reorganization all the assets, rights and obligations under the transactions of Wind Power Farm in Buciai-Kadariai villiages of the mentioned companies have been transferred to Šilalės vėjo Elektra, UAB. The Letter of Approval issued by the Host Party DFP for Vejo elektra, UAB states, that authorization is valid for the project participant (Vejo elektra, UAB) and any future owners of the project; hence, there was no need for Silales vejo elektra, UAB to apply to DFP with the request of LoA reissuance.

There are no project changes identified during the monitoring period. The project activity was completely operational during the monitoring period. The estimated annual net delivery to the grid was 35,957 MWh/year and was exceeded during the year 2012 (10,091 MW/h during the monitoring period and 38,922MWh total). Such difference (up to 10 %) is normal practice in wind power industry, taking into account that estimation of the annual net delivery is based on model calculations and on average wind speed when in practice it is different year by year.

3.4 Compliance of the monitoring plan with the monitoring methodology (94-98)

The monitoring occurred in accordance with the monitoring plan included in the PDD Version 1.4, dated 07/11/2011 regarding which determination has been deemed final and is so listed on the UNFCCC JI

All data sources for calculation emission reduction are clearly identified, reliable and transparent: monthly production reports issued by the grid operator (LIETUVOS ENERGIJA, AB), are used for calculating as the initial data source. The accounting is controlled both by the UAB Silales vejo elektra side and by LIETUVOS ENERGIJA, UAB, AB on the other side.

Default emission factors value (0,626 tCO2/MWh) is selected by carefully balancing accuracy and reasonableness, and appropriately justified of the choice in the final PDD. There is no requirement to review this emission factor during the crediting period.

The calculation of emission reductions is based in a transparent manner.

3.5 Revision of the monitoring plan (99-100)

Not applicable. Monitoring plan is not revised during the monitoring period.

Data management (101)

The monthly production data on supplied/consumed electric power segmented by day are sent once a month by grid operator LIETUVOS ENERGIJA, AB. The same reports are the basis for electricity sale and consumption invoices.

The production data are entered into the Monitoring protocol/net power calculation tool spreadsheet and compared with the data of the internal Winwind SCADA system of the wind park. Based on the monthly net production, the project assistant generates the annual production report which is the basis for GHG reduction calculations and the monitoring report.

The verification team has reviewed the Monitoring report against monthly production reports and respectively against electricity sale and purchase invoices on 100 % sample basis. No mistakes or misstatements have been found. Then monthly production reports was double checked with the SCADA system, deviation was found up to 1,5 % what is fully acceptable

taking into account uncertainties of the different measurement systems and transmission looses.

The calibration equipment is sealed and functioned without any failures during the monitoring period.

The evidence and records used for the monitoring are maintained in a traceable manner.

The data collection and management system for the project was found in accordance with the monitoring plan.

4 VERIFICATION OPINION

Bureau Veritas Certification has performed the 2nd monitoring period verification of "Wind Power Farm in Buciai and Kadariai Villages Joint Implementation Project", which applies the project specific methodology. The verification was performed on the basis of UNFCCC criteria and the host country criteria and also on the criteria given to provide for consistent project operations, monitoring and reporting.

The verification consisted of the following three phases: i) a desk review of the project design, baseline and monitoring plan; ii) follow-up interviews with project stakeholders; iii) resolution of outstanding issues and issuance of the final verification report and opinion. The management of UAB Silales vejo elektra is responsible for the preparation of the GHG emission data and the reported GHG emission reductions of the project on the basis set out within the within the project Monitoring Plan indicated in the final PDD version 1.4 (dated 07/11/2011). The development and maintenance of records and reporting procedures in accordance with that plan, including the calculation and determination of GHG emission reductions from the project, is the responsibility of the management of the project.

Bureau Veritas Certification verified the Monitoring Report version 1 (dated 26/02/2013) for the reporting period as indicated below. Bureau Veritas Certification confirms that the project is implemented as planned and described in the approved project design documents. The installed equipment being essential for generating emission reduction runs reliably and is calibrated appropriately. The monitoring system is in place and the project is generating GHG emission reductions.

Bureau Veritas Certification can confirm that the GHG emission reduction is accurately calculated and is free of material errors, omissions, or misstatements. Our opinion relates to the project's GHG emissions and resulting GHG emission reductions reported and related to the approved project baseline and monitoring, and its associated documents. Based on the information we have seen and evaluated, we confirm, with a reasonable level of assurance, the following statement:

Reporting period: From 01/10/2012 to 31/12/2012

Baseline emissions: 6,317 t CO₂ equivalents; Project emissions: 0 t CO₂ equivalents; Emission Reductions: 6,317 t CO₂ equivalents.
