LETTER OF APPROVAL JOINT IMPLEMENTATION PROJECT COLLECTION AND UTILIZATION OF METHANE FROM SOLID DOMESTIC WASTE GROUND IN LUHANSK CITY

By this letter National Environmental Investment Agency of Ukraine informs as follows:

1. Ukraine is a Party of the Kyoto Protocol to United Nations Framework Convention on Climate Change.
2. Ukraine makes the necessary efforts directed at fulfillment of conditions up to September, 01 2006 which are necessary for participation in mechanization of the Joint Implementation according to decisions of the 11th Conference of the Parties to United Nations Framework Convention on Climate Change which at the same time was the 1st Meeting of the Parties to the Kyoto Protocol.
3. National Environmental Investment Agency of Ukraine is appointed to be the body providing fulfillment of conditions of United Nations Framework Convention on Climate Change and introduction of mechanisms stipulated by Kyoto Protocol to it, body that is responsible for consideration and approval of projects directed at reduction of anthropogenic emissions volume or increase of greenhouse gas absorption according to Kyoto Protocol to United Nations Framework Convention on Climate Change.
4. Considering Joint Implementation Mechanism as a real opportunity for attraction of foreign investments into the projects aimed at reduction of greenhouse gas emissions, National Environmental Investment Agency of Ukraine has examined project documentation of the project "Collection and Utilization of the Methane from Solid Domestic Waste Ground in Luhansk City" (hereinafter referred to as – JI project) in the sense of the possibility of its qualification in the capacity of Joint Implementation Project which applicant is Nedra Luhanshchyny Limited Liability Company.
5. Based on results of project documentation examination and obtained expert results it was established that JI project fulfils conditions of art. 6 of Kyoto Protocol to United Nations Framework Convention on Climate Change and is approved as the Joint Implementation Project.
6. According to this decision and in compliance with art. 6 of Kyoto Protocol to United Nations Framework Convention on Climate Change National Environmental Investment Agency of Ukraine authorizes Nedra Luhanshchyny Limited Liability Company or any



- other next legal owner of JI project for actions that lead to transfer of emission reduction units (hereinafter referred to as – ERUs) received as a result of project implementation.
7. National Environmental Investment Agency of Ukraine will transfer verified quantity of ERUs within this scope obtained as a result of JI project implementation from the moment of project introduction to finalization of the first reporting period - end of 2012 to the Buyer within the mechanisms provided by art 6 and 17 of the Kyoto Protocol and decisions of the 11th Conference of the Parties to United Nations Framework Convention on Climate Change which at the same time was the 1st Meeting of the Parties to the Kyoto Protocol.
